Moreover, no one has offered rates for the supply of medicines. Therefore, medicines may be purchased from the approved firm of Government MCC of Khyber Pakhtunkhwa Health Department according to requirement within the sanctioned budget grant to avoid any audit objection at a later stage. Moreover, essential nature medicines may be purchased on quotation basis on the advice of Medical officer of jail hospital, after observing all legal and codal formalities under the rules.

I am further directed to convey that:-

- Supply of the ration items may be obtained from the contractors / suppliers concerned according to the required standard having 1st quality as per prescribed menu and no deviation is allowed at any cost.
- Security / call deposit should be obtained from the successful contractors strictly as per provision of Rule-12 of the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014.
- Agreements deed should be executed with the contractors concerned within a week time positively on the receipt of this letter and sent to this office at the earliest.
