I am further directed to convey that the rates tendered by contractors for the supply of the following items has not been recommended by the committee. Therefore, these items may be purchased on quotation basis according to actual requirement of Jails after observing all legal and codal formalities under the rules:-

1.	Milk Fresh
2.	Rice Joshi
3.	Mutton Fresh
4.	Electric Bulb

Moreover, no one has offered rate for the supply of medicines. Therefore, medicines may be purchased from the approved firm of Government MCC of Khyber Pakhtunkhwa Health Department to avoid any audit objection at a later stage. Moreover, essential nature medicines may be purchased on quotation basis on the advice of Medical officer of jail hospital according to actual requirement, after observing all legal and codal formalities under the rules.

I am further directed to convey that:-

- i. Supply of the required ration items may be obtained from the contractors / suppliers concerned according to the required standard having 1<sup>st</sup> quality as per prescribed menu and no deviation is allowed at any cost.
- ii. Security / call deposit should be obtained from the successful contractors strictly as per provision of Rule-12 of the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014.
- iii. Agreements deed should be executed with the contractors concerned within a week time positively of the receipt of this letter and sent to this office at the earliest.
