TERMS AND CONDITIONS

Every quotation will be sealed in two separate envelopes in the following manner:-

(a) Technical Proposal

- i. Every firm / vender should provide all the relevant documents/records that justify the legal, financial, managerial competency, capacity and capability of the firm / vender for completing the assignment.
- ii. Certificate to the effect that 2 % bid security has been annexed to the Financial Bid (without mentioning the amount) must be attached with Technical Bid.

(b) Financial Proposal

- i. The Quoted rates of the items must be inclusive of all the prescribed taxes which will be deducted from the bills of the suppliers. Bids offering rates excluding the taxes will be summarily rejected.
- ii. Financial Bid must be accompanied by a bid security @ 2% of total bid price (refundable) in the form of call deposit Receipt (CDR)/ Bank Draft in the name of Inspector General of Prisons, Khyber Pakhtunkhwa. In the absence of the bid security, the bid will be entirely regretted.
- iii. Contracting firms must be tax registered with Government of Pakistan. NTN & Sales Tax Number shall be mentioned in the bid & attested copies attached.

- iv. Sealed Bids must be sent/delivered to Inspector General of Prisons, Khyber Pakhtunkhwa Peshawar till 15th May, 2020 at 11:00 AM. The bids will be opened by the Procurement Committee on the same day at 11:45 A.M. in the presence of the bidders/their authorized representatives who opt to attend.
- v. Interested firms may obtain tender documents containing also the specifications of the items free of cost on the written request during office hours from the office of Inspectorate General of Prisons, Khyber Pakhtunkhwa, Peshawar. Tel: 091-9210334 from the date of publication of the notice till, 15th May, 2020 up to 10.00 AM. - vi. The specifications of the items are attached with the tender documents.
- vii. The bidder shall furnish an affidavit on Rs.100/- Stamp paper to the effect that the firm is not black listed in any Government Department and no suit with any purchaser is pending in any court of law.
- viii. Conditional, incomplete, unsigned and bid filled with led pencil or having overwriting will not be accepted.
- ix. The Committee reserves the right to accept or reject any or all the bids partially or wholly by assigning reason(s).
- x. The job should be completed within the time given in work/supply order. In case of delay, incomplete or substandard /below specifications supply, the bid security will be forfeited. The work/supply order will be rejected and the bid will be assigned to the next eligible bidder.
- xi. The cost incurred in case of above clause-x shall be borne by the Vender. No Payment will be made for incomplete/unsatisfactory job.
- xii. Supply of such items will be on FOR concerned Jails basis.
- xiii. Quantity of the items is tentative and can be increased / decreased according to the needs/ availability of funds.
- xiv. The Bidder will have to produce sample of the items and arrange demonstration as and when required by the Technical Committee.
